Spotlight on... the SA Voluntary Assisted Dying Review Board

The inaugural <u>South Australian Voluntary Assisted Dying Review Board</u> has been appointed, marking a historic milestone in the introduction of safe and compassionate access to voluntary assisted dying for eligible South Australians. The experienced eight-member Review Board, led by Dr Melanie Turner as Presiding Member, come from a broad range of professions, and represent expertise in health and medical care, legal, ethical and governance fields, as well as rich lived experience supporting people at the end of life.

The Review Board will play a varied and important role in the voluntary assisted dying process. They will monitor voluntary assisted dying assessments and forms to ensure the functions and powers of all people involved comply with the *Voluntary Assisted Dying Act 2021* (the Act) and promote continuous improvement in the quality and safety of support services for voluntary assisted dying in South Australia.

Dr Turner has shared some of her thoughts about the roles and responsibilities of the Review Board:

"Our responsibilities to the patients, family and clinicians involved in voluntary assisted dying are paramount. We exist to review the processes that have taken a long time to refine and come into legislation and the public are relying on this process to be clear, accessible, navigable, and compassionate".

"Our role in ensuring that all information for practitioners is suitable and accessible and that all steps in the process are respectful and followed well for each participant is our highest responsibility. Part of this will also be to provide feedback and data so



that the community and the Minister (for Health and Wellbeing) are able to see how voluntary assisted dying is working in South Australia and well as ongoing refinement of practitioner training and support".

"We are aware that as the first Voluntary Assisted Dying Review Board that the SA public are placing a lot of trust in us, and we will work hard to meet their expectations".

The next few months will feature the development of board practices, governance procedures and strategy documents, before the full powers and functions of the Board come into operation with the commencement of the Act.

Did you know?

Under the <u>Voluntary Assisted Dying Act 2021</u> (the Act), a relevant service provider has the right to refuse to authorise or permit the carrying out, at a health service establishment operated by that provider, of any part of the voluntary assisted dying process in relation to any patient at the establishment (including any request or assessment process).

A relevant service provider may include in the terms and conditions of acceptance of any patient into the health service establishment an acknowledgment by the patient that the patient:

- understands and accepts that the relevant service provider will not permit the establishment to be used for the purposes of, or incidental to, voluntary assisted dying; and
- b. agrees, as a condition of entry, that they will not seek or demand access to voluntary assisted dying at the establishment.

In relation to a patient at a health service establishment, if the patient advises a person employed or engaged by the relevant service provider at that health service establishment that they wish to access voluntary assisted dying, the relevant service provider who operates the establishment must ensure that:

- a. the patient is advised of the relevant service provider's refusal to authorise or permit the carrying out at the health service establishment of any part of the voluntary assisted dying process; and
- b. arrangements are in place whereby the patient may be transferred to another health service establishment or prescribed health facility at which, in the opinion of the relevant service provider, a registered health practitioner who does not have a conscientious objection to voluntary assisted dying is likely to be able to participate in a voluntary assisted dying process in relation to the patient; and
- c. reasonable steps are taken to facilitate the transfer if requested by the patient.

Individual service providers will need to consider policies and procedures that meet the requirements set out in the Act.
