| <p>Isolation:</p> <ul style="list-style-type: none"> Five (5) day isolation from work (day of test is day 0). RTW permitted on day 6 providing both below criteria are met: <ul style="list-style-type: none"> Asymptomatic for 24 hours prior to return and PPE (surgical mask) MUST always be worn on site for 10 days (both clinical and non-clinical areas) <p>IF SYMPTOMS REMAIN on day 5 staff are NOT PERMITTED to return to work until 24 hours after symptoms have resolved.</p> <p><i>**Managers and individual staff members are responsible to ensure strict adherence to the above**</i></p> <p>PPE: Surgical mask on site at all times when returning to work up to and including day 10. <i>This includes clinical and non-clinical zones.</i></p> <p>Tests accepted: RATs and PCRs both accepted and RATs must be registered with SA Health. <i>Evidence must be provided to line managers.</i></p> <p>Other: SA Health RAT Registration link: SA Health Online RAT Registration link</p> | <p>Isolation: Nil - Can remain working if asymptomatic <i>and</i> RAT negative.</p> <p>Test required: Daily RATs before all shifts up to and including day 10.</p> <p>PPE: Surgical mask on site at-all-times up to and including day 10. <i>This includes clinical and non-clinical zones.</i></p> <p>Other: Must be asymptomatic to work. <i>**Refer to column 4 if symptoms develop.</i></p> | <p>Isolation: Nil</p> <p>Test required: RAT test prior to returning to work must be negative. Nil further testing required unless symptoms develop (<i>refer to column 4</i>).</p> <p>PPE: Surgical mask on site at-all-times up to and including day 10. <i>This includes clinical and non-clinical zones.</i></p> <p>Other: Must be asymptomatic to work. <i>**Refer to column 4 if symptoms develop.</i></p> | <p>Isolation: <i>Must not work when symptomatic.</i></p> <p>Test required: If RAT negative <i>with</i> symptoms:</p> <p><i>*If COVID negative, RTW 24 hours after respiratory viral symptoms have completely resolved. Or 48 hours after gastro symptoms have resolved.</i></p> <p><i>*If COVID positive - refer to column 1, COVID positive rule for RTW.</i></p> <p><i>Note: RTW post other illness/ virus’s – refer to local policy/procedure and/or call Staff Health for advice (82820792, ext. 20792).</i></p> |

Notes:

- RATs can be obtained from Staff Health at both Lyell McEwin and Modbury.
- PCR tests are no longer required unless directed to do one by Staff Health (certain circumstances will apply)

- Employees/Contractors etc are no longer required to notify Staff Health of positive results and must report to their Divisional direct line manager however Staff Health are available for advice via phone: **08 8282 0792**.
